In case of retired officials of Govt. organization, the remuneration shall be fixed either as per the formula of last pay drawn minus pension OR as mentioned in the advertisement (i.e. ₹. 40,000/- to 45,000/-), whichever is less. Mandatory deduction, if any, will be made. There will be no annual increment/percentage increase during the contract period.
