#### TERMS AND CONDITIONS FOR SELLING SUGARCANE JUICE AT IIT ROPAR CAMPUS

#### **Eligibility criteria:-**

The intending applicant must fulfill the following eligibility criteria:-

- 1. The applicant must be a **citizen of India**.
- 2. The applicant must be **of legal age (a major)**.
- 3. The applicant must be capable of installing an Automatic Sugarcane Juice Machine equipped with the latest technology.
- 4. The applicant must possess a valid PAN card. A copy of the PAN card must be attached.

#### **General Terms & Conditions:-**

1. The monthly rent and security for the sugarcane juice shops shall be as follows:-

\* The successful applicant shall have to deposit a security amount in the shape of Demand Draft/ FDR duly pledged in favour of Registrar, Indian Institute of Technology Ropar valid for a period of one year plus three months from the date of issue of the work order.

- 2. The contract will initially be for a period of one year and it may be extended for a further period of three years on annual basis after reviewing the performance of the firm by the Utility Management Committee and on mutual consent with agreed upon terms and conditions.
- 3. The applicant must assess the work/business before submission of his application.
- 4. The rates to be quoted should be inclusive of delivery and other incidental charges etc.
- 5. The applicant should abide by the IIT Ropar rules and regulations.
- 6. The applicant should not assign the contract to any other person or allow any person to interfere in the management of the abovesaid business.
- 7. In case the applicant fails to render services to the satisfaction of the IIT Ropar Authority, the IIT Ropar shall be at liberty to get the work done by any other party or to enter into a fresh Contract for the remaining period at applicant's risk and expenses.

- 8. In the event of committing any breach of Terms & Conditions contained herein by the applicant, the IIT Ropar shall be at Liberty to terminate the Agreement forthwith and without prejudice to other rights and shall be entitled to forfeit the due payments if any and recover the Institute dues (water/electricity/rent) from Security Deposit.
- 9. The provision of appropriate manpower, material supplies required for performing the tasks/processes of the abovesaid Services shall be borne by the applicant and other necessary appliances required for completing the Job shall also be arranged by the applicant.
- 10. Institute is following the policy of "Say No to Single Use Plastic" which requires to be followed by the application after the award of contract.
- 11. The timing for operating these shops shall be communicated to the vendor by the Utility Management Committee separately.
- 12. No permanent space would be allotted.
- 13. The rent would be deposited in advance by 5<sup>th</sup> of every month to the Estate & Maintenance Office/IIT Ropar.
- 14. The security amount requires to be deposited before the start of their services.
- 15. These vendors will be allowed permission inside IIT Ropar campus by fulfilling all security procedures including issuing Vendor's card by the Security office.
- 16. The monthly rent will be reviewed by the Committee from time to time.
- 17. The Committee reserves the right to discontinue the services of any vendor without issuing any notice i.e. the Contract may be terminated or revoked at the discretion of IIT Ropar without assigning any reason at any time.
- 18. The Director, IIT Ropar reserves the right to reject any or all Tenders without assigning any reason.
