#### 1. Local Committees

- 3. One faculty member from other department (to be nominated by Director)

#### Staff Grievance Redressal Committee:

- 1. Associate Dean, FA&A (Chairman)
- 2. Dy. Registrar (to be nominated by Director)
- 3. Joint Registrar (Member Secretary)

#### 2. Referral Centralized Grievance Redressal Committee

There shall be a Referral Centralized Grievance Redressal Committee which shall peruse the unresolved grievances referred to it by the Local committees. Its constitution shall be as follows:

- 1. Dean (FAA)/ Associate Dean (FA&A) (Chairperson)
- 2. Senior most Professor
- 3. Chairperson of Women Cell (Ex-officio)

- 4. Joint Registrar, Member Secretary (for Non-Faculty). In case of faculty, the Member Secretary will be one who is member secretary of his/her Departmental Grievance Redressal Committee.
- 5. Chief Vigilance Officer Invitee
- 6. Institute Counsellor (to be nominated by Director) Invitee
- 7. Internal Auditor Invitee
- 8. Institute Legal Advisor Invitee

#### 3. Mode of Redressal:

The aggrieved party shall lodge his/her complaint in writing to the Member Secretary of the relevant Committee. The Member Secretary shall communicate the complaint to the complainee seeking his/her version. The Committee shall peruse the complaint as well as the response of complaints, and may also call either or both parties for interaction. Subsequently the committee may submit its response to the Director for further necessary action.


