Certification requirement: Bid ATC require s TCO EPEAT certification to qualify bid. In light of to the above, as per the Departme nt for Promotion of Internal Trade (DPIIT) Office Memorandum No. P- 45014/33/2021-BE-ii (e64737) dated Dece mber 20, 2022, it has been mandated tha t any restrictive and discriminatory conditi ons against local suppliers should not be p art of tenders or bids. This directive ensur es a fair and equitable opportunity for loc al manufacturers and suppliers to particip ate in public procurement processes. Also GOI OM 33(3)/201724.01.2018, also notifi ed that TCO,EPEAT,MI,Energy Star are not relevant to India & due to lack of adequat e testing facilities this certification is not c omplied with by LOEM, and support only MNC brands. This quality certification req uirement could be fulfilled by Indian qualit y certifications such as BEE, BIS and EPR. Thus, please allow Indian certificate as we II.	Kindly see the corrigendum for your query, please. Certification : FCC, CE, RoHS, TCO 9.0, UL, E nergy Star/BEE (For EPEAT Gol d/EPEAT equivalent certificate needs to be attached). - 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
