### ITEM NO.6 TO CONSIDER THE BUDGET ESTIMATES FOR FINANCIAL YEAR, 2020-21 OF IIT ROPAR.

The Board considered the Budget Estimates (Annual Plan) submitted for the Financial Year 2020-21 to MHRD on 10.12.2019 under Object Head 31, 35 & 36. The Board noted that the Institute has not even received the approved grant. However, against the requested budget MoE allocated the following for the Financial Year 2020-21: -

The Board also noted the minimum quarterly budget requirement under OH- 31 is ₹ 20 crore and in OH-35 is ₹ 10 crore. With the present allocation IIT Ropar will not be even able to meet the following expenditure

- a) Fellowship / Scholarship Expenses
- b) Outsourcing (Transit & Main Campus)
- c) Security Service Charges (Transit/ Main Campus)
- d) Housekeeping & Maintenance Expenses
- e) Telephone & Internet Expenses
- f) Electricity & Water Charges Transit & Main Campus.
- g) Transport charges for maintaining two campuses.
- h) Maintenance of the Institute

In addition to the above IIT Ropar will also require an amount of ₹ 3 crore (1.6 crore for salaries and another 1.4 for furniture) for KV Sangathan school which is going to start during the current academic year. The Board decided that the MoE may be urged to release the monthly funds as per the annual allocation since we have negative in OH31 & OH 35 at the earliest.

RESOLUTION: BG33/R6/33/523 RESOLVED THAT the Institute shall manage expenditure in allocated budget, and the Ministry is also urged to release the Grantin-Aid as per the annual allocation on quarterly basis preferably at the beginning of the subsequent quarters to tide over the negative balance in OH31 & OH 35.

RESOLVED FURTHER THAT for additional grant, demand will be raised during supplementary/RE stages.

ITEM NO. 7 TO CONSIDER THE OPENING OF NEW KENDRIYA VIDYALAYA UNDER INSTITUTE OF HIGHER LEARNING SECTOR IN THE CAMPUS OF IIT ROPAR PUNJAB AND APPROVE THE PROPOSAL TO TAKE ADMISSION (BY OTHER CATEGORIES) IN KENDRIYA VIDYALAYA AT IIT ROPAR Jt. Commissioner (Pers) Kendriya VidyalayaSangathan has informed IIT Ropar vide his letter No: F.11-Adm1073P/18/2018-Admn-I/479 dated 13.03.2020 that Hon'ble Minister of HRD-cum-Chairman, KVS has approved the opening of new Kendriya Vidyalaya under Institute of High Learning Sector, in the campus of IIT Ropar and also requested the following:

- Opening of Escrow account in the name of "IIT Ropar, School Fund Account" and deposit the sum of ₹ 80,00,000/- (Rupees Eighty Lakhs Only) as advance required for 6 months for running the newly opened KV from class I to V. This account will be additional to the usual School Fund Account.
- 2. Handing over of building and infrastructural facilities.
- 3. Liaise with DC, KVS RO Chandigarh for putting all logistic in place.

The Board considered the above-mentioned request and also considered the allocation of additional grant of ₹ 3 crores (₹ 1.6 crores for salaries and 1.4 crore for furniture etc.) for opening of KV School at IIT Ropar Campus.

The KV at IIT Ropar may be start functioning from the Academic Year 2021-22 and the Board approved the following proposed categories of students to take admission in the KV, IIT Ropar in the order of priority as listed below:

- a) Children of employees (Regular/Contract/Deputation)
- b) Children of Students or Scholars
- c) Grand Children of Regular Employees
- d) Grand Children of Regular Retired Employees
- e) Children of Outsourced/Contractual employees

RESOLVED THAT the commencement of classes from the Academic Year 2021-22and the categories of admissions are approved.

RESOLVED FURTHER THAT the Escrow account may be opened once the funds are received from the Ministry.

#### ITEM NO. 8 TO CONSIDER THE AUDIT AND INSPECTION REPORT OF IIT ROPAR FOR THE FINANCIAL YEAR 2018-19 AND CLASSIFICATION OF OUTSTANDING CAG PARAS AS PER AUDIT REPORT.

The Board considered the audit and inspection Report of IIT Ropar for the Financial Year 2018-19.

#### ITEM NO. 9 TO CONSIDER THE RECOMMENDATION OF THE BUILDING & WORKS COMMITTEE FOR ENHANCEMENT OF INTERNAL DRAINAGE SYSTEM AND REPAIR OF THE FLOOD DAMAGED BOUNDARY WALL OF IIT ROPAR PERMANENT CAMPUS

The Board considered the recommendation made in 26<sup>th</sup> Finance Committee meetings on the proposal. The Board noted that the terminology "Flood mitigation works" had wider ramification and hence the B&WC in its 33<sup>rd</sup> meeting decided to change it to "Enhancement of Internal Drainage System of IIT Ropar (EIDS)" as suggested by the Chairman, Flood mitigation committee and CPWD. The committee unanimously agreed for repair/reconstruction of damaged boundary wall with grills to avoid dam break scenario as happened early during floods of August, 2019. The Board agreed to the Finance Committee recommendation for A/A & E/S of ₹ 83 Lacs for the works. The proposal of Enhancement of Internal Drainage System of IIT Ropar towards one of the flood mitigation measure was discussed at

length and the Board decided to approve for the proposal of Enhancement of Internal Drainage System of IIT Ropar to the tune of ₹ 9 crores. The expenditure for this work should be incurred subject to availability of funds to be released by MoE since the Institute is already stressed in Finances. However, the cost of reconstruction/ repair of boundary wall will be met by the Institute from the savings of phase-1 works.

However, expenditure will be subject to availability of funds to be released by MoE. #### ITEM NO. 10 TO CONSIDER AND APPROVE THE WORK OF SHIFTING ONE DOUBLE CIRCUIT OF 220 KV TRANSMISSION LINE PASSING THROUGH THE IIT ROPAR CAMPUS ACADEMIC AND HOSTEL ZONE.

The Board considered the proposal and agreed to shift of 220KV transmission line as it is passing through the student's zone. The committee appreciated the efforts made by the Institute with the Honorable Chief Minister of Punjab and State Govt. officials for seeking waiver of ₹ 3.57 crore towards the demand raised by PSTCL. The representative of State Govt. assured that the state would surely consider the request and take up the issue of waiver of shifting charges. The Board agreed to the Finance Committee

recommendations for shifting of transmission line through the

campus.

## RESOLUTION: RESOLVED THAT the shifting of 220 KV transmission line within the campus is approved.

RESOLVED FURTHER THAT the expenditure consequent to full/partial the waiver by the State Govt. may be met from the savings of Phase-1 work/ the approved project cost for construction of Main Campus.

#### ITEM NO. 12 TO CONSIDER THE DISCONTINUATION OF (BTECH-MTECH) DUAL DEGREE PROGRAMME FROM THE ACADEMIC YEAR 2020-21.

As per recommendation of the Senate, the Board approved the discontinuation of admission to the (B.Tech-M.Tech) Dual Degree program through JEE-Advanced from the Academic Year 2020-21.The Board considered the discontinuation of B.Tech-

M.Tech (Dual Degree) programme in Mechanical Engineering from the Academic Year 2020-21.

RESOLUTION: RESOLVED THAT the discontinuation of BG33/R12/33/529 (B.Tech-M.Tech) Dual Degree programme from the Academic Year 2020-21 is approved.

#### ITEM NO. 13 TO CONSIDER THE PROPOSAL TO RELAX NORMS OF EXISTING ENTRENEURSHIP POLICY FOR FACULTY & RESEARCH SCHOLARS (Ph. D STUDENTS) AT IIT ROPAR

As per the discussion of Director/Chief Coordinator TBIF with IIT Madras & IIT Delhi incubators for ascertaining the policies on faculty based start-ups, the following proposed amendments are considered by the Board in existing entrepreneurship policy for faculty & research scholars (Ph.D Students) at IIT Ropar:

1. As per the existing policy, the faculty has to take leave to play executor/ promoter/ director (paid) role in a start-up companies. However, there is always a risk of failure of such start-ups, which discourages several faculties to take risk of availing leave to have his/her own start-ups. There are several requests from faculty to permit them to try such a start-up on trial basis without taking due leave. Therefore, it is proposed that the faculty may be allowed to have his/her start-up company as an executor/promoter/director (paid) without taking due leave. Other terms and conditions including sharing of equity shall remain same as per the existing policy. The proposed trial period will be for maximum of one year from the date of incubation. In case the faculty wishes to continue his/her start-up company beyond one year, he/she will have to take due leave as per the provisions of the existing policy. This clause will be applicable provided they go though the incubation process of

IIT Ropar TBIF.

(Prof. Sarit Kumar Das) Director 2. Similar to the above proposal for faculty, it is further proposed that Ph.D Students may also be given such relaxation. However, the Ph.D Students will need recommendations of his/her guide &HoD, followed by approval of Dean, Research. This clause will be applicable provided they go through the incubation process of IIT Ropar, TBI.

#### RESOLUTION: RESOLVED THAT the proposed BG33/R13/33/530 amendments in the existing entrepreneurship policy for Faculty & Research Scholars (Ph.D Students) at IIT Ropar are approved.

#### ITEM NO. 14 TO CONSIDER AND APPROVE COLLABORATION OF BRITISH COUNCIL AND IIT ROPAR PARTNERSHIP TO IMPLEMENT NEWTON BHABHA FUND PROGRAMME

The Board considered the proposal presented by the Associate Dean (International Relations) for collaboration of British Council and IIT Ropar partnership to implement Newton Bhabha Fund Programme and noted that no extra expenses are foreseen in the Current and next FY for IIT Ropar students to participate in this programme. Moreover, due to prevailing COVID-19 situation, no incoming UK students will be hosted at IIT Ropar in 2019 and 2020, thereby ensuring that no extra expenses are incurred till the current academic year. The office of International Relations at IIT Ropar will coordinate this partnership.

# RESOLUTION: RESOLVED THAT the proposal for collaboration of British Council and IIT Ropar partnership to implement Newton Bhabha Fund Programme is approved.

#### ITEM NO. 15 TO CONSIDER THE STATUS OF RESEARCH PRODUCTIVITY OF THE FACULTY MEMBERS IN EACH IITS AND TO TAKE STOCK OF THE NUMBER OF FACULTY MEMBERS WHO HAVE NOT PUBLISHED IN REPUTED JOURNALS FOR THE LAST THREE YEARS.

The Board considered the status of research productivity of the faculty members of IIT Ropar and took stock of the number of faculty members who have not published in reputed journals for the last three years. The Board authorized the Director to take appropriate steps to encourage faculty members for publication those who do not have any publications in the reputed journals.
