The Executive Engineer, IIT Ropar for and on behalf of the Director, IIT Ropar invites item rate quotation in the attached format from the bonafide agencies and eligible registered contractors of CPWD/ PWD B&R/ MES/ PUDA/Railway/BSNL, other registered contractors Central/State Government and specialized agency having experience of epoxy paint work for the following work at permanent campus of IIT Ropar.

- 1. ELIGIBILITY CRITERIA:-
- i. Contractor / agency who fulfill the following requirements shall be eligible to apply:
 - a) Should have completed the works during last seven years ending on previous day of last day of submission of quotation out of which at least one should have been executed in Government Departments as mentioned below :

3 (three) Similar Works* each of value not less than 40% of the estimated cost put to quotation.

OR

2(two) Similar Works* each of value not less than 60% of the estimated cost put to quotation.

OR

1(one) Similar Works* of value not less than 80% of the estimated cost put to quotation.

*Similar Works means "Civil Works"

- b) Enlistment contractors of appropriate class in Central & State Government and Organization / Specialized firm undertaking epoxy paint work.
- c) Joint Ventures are not accepted.
- ii. Documents to be submitted with the Quotation:
 - a) EMD Declaration Form (Format B).
 - b) Enlistment order of the contractor/ Registration of firm/ Specialization certificate.
 - c) Required experience/ completion certificate of work.
 - d) GST Registration.
 - e) Signature on all pages.
 - f) PAN registration with the Income Tax Department.
 - g) Price quoted in the Prescribed Format "A". Signed and stamped.
 - h) Signature & stamp.

Envelope of sealed quotation should superscribe the Name of work, date & opening of quotation.

- The Quotation must be submitted in the Tender box placed in Works and Estate Section, Second floor, East Wing M. Visvesvaraya Block, Permanent Campus, IIT Ropar- 140001 on or before 22.03.2022 upto 3:00 PM & shall be opened on the same day at 3.30 PM in the presence of bidders or their representatives, who may like to be present.
- 3. The quotations received through Email shall not be entertained.
- 4. Prices should be quoted in the prescribed Format "A". No advance payment will be made to the agency.
- 5. Conditional quotations shall be rejected.
- 6. Duration of work shall be 7 days from the issue of work order.
- 7. The quotation shall be valid for 30 days.
- 8. The rate quoted shall be inclusive of all taxes including Goods and Services Taxes (GST).
- 9. Nothing extra will be paid to the agency by the Institute.
- 10. The work can be terminated at any time without giving any reason and notice.
- 11. Debarred agency/ or individual shall not participate in the Quotation process.
- 12. Bidders may inspect the site of execution of work before submission of quotation to understand the , scope of work in all respects. The drawings of the site are also attached.
- 13. The quantities of items in the schedule are tentative which may increase or decrease depending upon site conditions.
- 14. Security deposit @ 2.5% of the value of work done shall be deducted and released after satisfactory completion of defect liability period of three months from the date of completion of work.
- 15. Liquidated Damages: Compensation for delay of work with maximum rate @ 1% (one percent) per month of delay to be computed on per day basis based on quantum of damage suffered due to stated delay on the part of Contractor
- 16. The Director, IIT Ropar reserves the right to cancel any or all quotations without assigning any reason.
- 17. Enclosure : Format "A"
- 18. Arbitration: In the unfortunate situation if any and all disputes, disagreements and controversies arising in any manner, which cannot be settled by mutual agreement between the two parties, shall be resolved through arbitration. The number of arbitrators shall be ONE, shall be appointed by the Director, IIT Ropar. The decision of the sole arbitrator shall be final and binding to both parties. All provisions of Arbitration and Conciliation Act 1996 (with amendments) shall apply and the legal place of arbitration shall be Rupnagar, Punjab. The language of arbitration proceedings shall be English. The Court which has jurisdiction in the matter is District Court, Rupnagar, Punjab.

As per today's meeting in the workshop, the total calculated epoxy flooring area for individual colour coding are given below:-

For block-5, (Conventional Workshop) Red colour area = 2565 square feet Green colour area = 1126 square feet Yellow colour area = 969 square feet

For block-2 (CNC Shop + gate corridor) Sky blue / green area = 815 square feet

Total epoxy flooring area for block-2 and block-5 are = 5475 square feet
