NOTICE REGARDING WRITTEN TEST (ADVT 01/2024)

- 1. This is for the information of all those candidates who had applied for the above posts that the written test for these posts has been scheduled as mentioned above and call letters have been issued through email to all the candidates who had applied for the post.
- 2. The candidates are advised to check their email including the spam folder regarding the call letter issued for the written examination. The Institute will not be responsible for non-checking of email by the candidate.
- 3. If any candidate had applied for the said post but did not receive the call letter through email, he/she should inform this Institute immediately on email id <u>recruitment@iitrpr.ac.in</u> latest by **15.12.2024**. No such request would be entertained after **15.12.2024**. While sending the email you should mention the subject as Non-receipt of Call letter for the post of _____.

- 4. Before appearing for the written test, the candidates must ensure that they fulfill the advertised eligibility criteria as mentioned in advertisement no. 01/2024 and only those candidates who fulfil the eligibility criteria as per the advertisement in all respects need to appear for the written examination.
- 5. Submission of fake, untrue, fabricated, distorted information in online applications and documents thereof shall lead to disqualification of candidates at any stage of the recruitment. Please note that even if you qualify in the written test & subsequently it is found that the candidate does not fulfil the advertised eligibility criteria, his/her candidature will be cancelled at any stage of the recruitment, such candidate shall not have any claim of employment with IIT Ropar in above circumstances.
- 6. The candidates who qualify the written test and also fulfill the eligibility criteria would be called for a trade test at a later date, the details of which would be intimated later.
- 7. No TA would be paid for appearing in the written test. However candidates called for the trade test would be paid 2nd sleeper Class Railway fare from the place of duty/residence to IIT Ropar and back by the shortest route. The amount of TA will be remitted by Transfer to the bank account of the candidate and will not be paid on the spot. The TA claim will be passed on production of Railway tickets. Please note that the train tickets should be booked by utilizing the services of government authorized travel agent i.e. Indian Railways Catering and Tourism Corporation. Ltd. (IRCTC).
- 8. The appearing in the written test is strictly provisional and should not be construed as being eligible for the selection process for the said post on the basis of being called for the written test. The eligibility of the candidate as per the advertised criteria would be checked at any stage during the recruitment process and the non eligible candidates would be disqualified.
