- i) M.Tech Degree in Computer Science / Information Technology or equivalent qualification with a minimum of 55% marks in the qualifying degree from a recognized University/Institute with 06 years relevant experience in the Level-11 as per 7th CPC or equivalent.  
OR
- ii) Master Degree in Computer Science/IT, Computer applications or equivalent qualification with a minimum of 55% marks in the qualifying degree from a recognized University/ Institute with 10 years relevant experience in Level-11 as per 7th CPC or equivalent.  
OR
- iii) Bachelors Degree (four years) in Computer Science / Information Technology Engineering or equivalent qualification with a minimum of 55% marks in the qualifying degree from a recognized University/ Institute with 13 years relevant experience in Level-11 as per 7th CPC or equivalent.

In addition to above, candidates who are presently working on analogous pay scale ie Pay level 12 in Central Govt/ State Govt/ Autonomous bodies of Central & State Govt including PSUs and having relevant experience are also considered.

The age limit was considered upto 50 years.
