- 2. Separate schedule of quantity is included in this tender for civil and electrical items of work. The contractor shall quote the item rates in figures and words accurately so that there is no discrepancy in rates written in figures and words.
- 3. Time allowed for the execution of work is 30 days.
- 4. The contractor(s) shall submit a detailed program of execution in accordance with the master programme / milestone within 7 days from the date of issue of award letter.
- 5. Quality of the project is of utmost importance. This shall be adhered to in accordance with the provisions of CPWD specifications and guidelines given in the relevant paras. The contractor shall at all times indemnify and keep indemnified the owner and its officers, servants and agents from and against all third party claims whatsoever (including time not limited to property loss and damage, personal accident, injury or death of/or property or person of any sub-contract and or the servants or agents of the contractor any subcontractor(s) and or the owner and the contractor shall at his own cost and initiative at all times, maintain all liabilities under Workman's Compensation Act/ Fatal Accident Act, Personal Injuries, Insurance Act and/ or their Industrial Legislation from time to time in force.
- 6. For electricity requirements for carrying out work, the contractor(s) shall be provided with temporary electric connection at suitable place by the Institute if possible, on request of the contractor. The required cable and electrical meter shall be arranged by the contractor. The monthly consumption of electricity shall be recovered from the running bills of the contractors on the approved rates of the

Institute. The institute cannot be held liable to provide any office or location to set up office.

- 7. The schedule of requirement is as per Annexure 'A' & the evaluation of bid will be on the basis of total bid value
- 8. The rates quoted shall be inclusive of all taxes, duties octroi, works contract tax, cartage loading, GST and any other statutory taxes complete in all respects, valid for a period of one year from the date of award of contract.
- 9. Bid security of the unsuccessful bidders will be returned to them.
- 10. In the event of any breach of the terms of the contract, the contractor shall have to bear the penalty specified in the present terms. However, upon a material breach of the contract terms which is not remedied by the contractor within 7 days, IIT Ropar shall be entitled to terminate the present contract without any notice and the contractor shall be required to make good any damage incurred by IIT Ropar.
- 11. The service provider shall at his own risk and cost ensure that their employees deployed to carry out the work of IIT Ropar are insured against all risks that may be associated with the job.
- 12. Labour Laws: The contractor will follow all labour laws / acts of Central Govt., Local Govt. applicable from time to time. He should maintain proper attendance register and record of wages paid to the workers and these documents should be submitted to IIT Ropar while raising their monthly bills along with record of complaints and whenever asked. He will obtain necessary Labour license required for engaging labour at site. The bidder should note that wages paid to the workers by the contractor should not be less than minimum wages notified by the Chief Labour Commissioner (Central) from time to time for their respective category. The agency shall comply with all Acts, Laws and Regulations applicable to the area with regard to performance of the work and including, Minimum Wages Act, 1948, Contract Labour (R&A) Act, 1970, Workmen's Compensation Act, 1923 Industrial Dispute Act, 1947 and take such steps as may be deemed necessary in this regard.

It will be solely contractor's responsibility to face any consequences arising out of non compliance of various labour laws. Force Majeure: Neither party shall bear responsibility for the complete or partial nonperformance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the present contract), if the non-performance results from such Force Majeure circumstances as Flood, Fire, Earth Quake, Pandemic and other acts of God as well as War, Military operation, blockade, Acts or Actions of State Authorities or any other circumstances beyond the parties control that have arisen after signing of the present contract. In such circumstances the time stipulated for the performance of an obligation under the present contract is extended correspondingly for the period of time of action of these circumstances and their consequences.
- 14. Arbitration: In the unfortunate situation if any all disputes, disagreement and controversies arising in any manner, which cannot be settled by mutual agreement between the two parties, shall be resolved through arbitration. BETWEEN

IIT ROPAR represented through its Registrar, (Hereinafter referred as the 'Principal/ Owner', which expression shall unless repugnant to the meaning or context hereof include its successors and permitted assigns)

AND

Preamble

WHEREAS the Principal / Owner has floated the Tender (NIT No.)

(hereinafter referred to as "Tender/Bid") and intends to award, under laid down organizational

procedure, contract for *Illumination of hockey field at sports complex in IIT Ropar permanent campus* hereinafter referred to as the "Contract".

AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s).

AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "Integrity Pact" or "Pact"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

Article 1: Commitment of the Principal/Owner

- 1. The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
 - a. No employee of the Principal/Owner, personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
 - b. The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Principal/Owner will, in particular, before and during the Tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the Tender process or the Contract execution.
 - c.The Principal/Owner shall endeavour to exclude from the Tender process any person, whose conduct in the past has been of biased nature.
 - d. If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

Article 2: Commitment of the Bidder(s)/Contractor(s)

1. It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of fraud or corruption or Coercion or

Collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.

- 2. The Bidder(s)/Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:
 - a. The Bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal/Owner's employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the Tender process or during the execution of the Contract.
 - b. The Bidder(s)/Contractor(s) will not enter with other Bidder(s) into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process.
 - c. The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/Contract(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
 - d. The Bidder(s)/Contractor(s) of foreign origin shall disclose the names and addresses of agents/representatives in India, if any. Similarly Bidder(s)/Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on
 - Behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent / parallel tender for the same item.
 - e. The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.

- 3. The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- 4. The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practice means a willful misrepresentation or omission of facts or submission of fake/ forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.
- 5. The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/ her reputation or property to influence their participation in the tendering process).

Article 3: Consequences of Breach

Without prejudice to any rights that may be available to the Principal/Owner under law or the

Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder/ Contractor accepts and undertakes to respect and uphold the Principal/Owner's absolute right:

- 1. If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/ determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. Such exclusion may be forever or for a limited period as decided by the Principal/Owner.
- 2. Forfeiture of EMD/ Guarantee/ Security Deposit: If the Principal/ Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner

apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/ Contractor.

3. Criminal Liability: If the Principal/Owner obtains knowledge of conduct of a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of IPC Act, or if the Principal/Owner has substantive suspicion in this regard, the Principal/ Owner will inform the same to law enforcing agencies for further investigation.

Article 4: Previous Transgression

- 1. The Bidder declares that no previous transgressions occurred in the last 5 years with any other Company in any country conforming to the anti corruption approach or with Central Government or State Government or any other Central/State Public Sector Enterprises in India that could justify his exclusion from the Tender process.
- 2. If the Bidder makes incorrect statements on this subject, he can be disqualified from the Tender process or action can be taken for banning of business dealings/ holiday listing of the Bidder/Contractor as deemed fit by the Principal/ Owner.
- 3. If the Bidder/Contractor can prove that he has resorted / recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal/Owner may, at its own discretion, revoke the exclusion prematurely.

Article 5: Equal Treatment of all Bidders/Contractors/Subcontractors

- The Bidder(s)/Contractor(s) undertake(s) to demand from all subcontractors a commitment in conformity with this Integrity Pact. The Bidder/Contractor shall be responsible for any violation(s) of the principles laid down in this agreement/Pact by any of its Subcontractors/ sub-vendors.
- 2. The Principal/Owner will enter into Pacts on identical terms as this one with all Bidders and Contractors.
- 3. The Principal/Owner will disqualify Bidders, who do not submit, the duly signed Pact between the Principal/Owner and the bidder, along with the Tender or violate its provisions at any stage of the Tender process, from the Tender process.

Article 6- Duration of the Pact

This Pact begins when both the parties have legally signed it. It expires for the Contractor/Vendor 12 months after the completion of work under the contract or till the continuation of defect liability period, whichever is more and for all other bidders, till the Contract has been awarded.

If any claim is made/lodged during the time, the same shall be binding and continue to be valid despite the lapse of this Pacts as specified above, unless it is discharged/determined by the Competent Authority.

Article 7- Other Provisions

- 1. This Pact is subject to Indian Law, place of performance and jurisdiction is the Headquarters of the Principal/Owner, who has floated the Tender.
- 2. Changes and supplements need to be made in writing. Side agreements have not been made.
- 3. If the Contractor is a partnership or a consortium, this Pact must be signed by all the partners or by one or more partner holding power of attorney signed by all partners and consortium members. In case of a Company, the Pact must be signed by a representative duly authorized by board resolution.
- 4. Should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
- 5. It is an agreed term and condition that any dispute or difference arising between the parties with regard to the terms of this Integrity Agreement / Pact, any action taken by the Owner/Principal in accordance with this Integrity Agreement/ Pact or interpretation thereof shall not be subject to arbitration.

Article 8- LEGAL AND PRIOR RIGHTS

All rights and remedies of the parties hereto shall be in addition to all the other legal rights and remedies belonging to such parties under the Contract and/or law and the same shall be deemed to be cumulative and not alternative to such legal rights and remedies aforesaid. For the sake of brevity, both the Parties agree that this Integrity Pact will have precedence over the Tender/Contact documents with regard any of the provisions covered under this Integrity Pact. - **1.** In the Contract (as hereinafter defined) the following definitions words and expressions shall have the meaning hereby assigned to them except where the context otherwise required.
 - a. "Institute / Department" shall mean the Indian Institute of Technology Ropar (IIT Ropar)
 - b. The "President" shall mean the Board of Governors, IIT ROPAR.
 - c. The term "Director General of Works" shall mean the Director, IIT Ropar.
 - **d.** "Superintending Engineer" shall mean the Registrar of the Institute, who as overall In charge and head of the administration shall direct the contract.
 - **e.** The "Engineer-in-charge", who shall administer the work, shall mean the Executive Engineer, IIT Ropar.
 - **f.** "Accepting authority" shall mean the Registrar, IIT ROPAR on behalf of the Director.
 - **g.** "Site Engineers" shall mean the AEE (Civil)/ Junior Engineer (Civil)/Junior Engineer (Electrical)/ Engineer appointed by the Works & Estate department.
 - **h.** No labour huts/ jhuggies shall be allowed to be constructed in the campus except for the security persons at work site with proper sanitation arrangements after due approval of the Registrar.
 - **i.** Any damage caused to the existing roads, power cables, telephone cables, water lines and structures by the contractor's equipment, shall have to be made good by the contractor at his own cost.
 - **j.** Existing drains, pipes, cables, over-head wires, sewer lines, water lines and similar services encountered in the course of the execution of work shall be protected against the damage by the contractor at his own expense. The contractor shall not store materials or otherwise occupy any part of the site in a manner likely to hinder the operation of such services.
 - **k.** No payment shall be made to the contractor for any damage caused by rain, snow fall, floods, earthquake or any other natural causes whatsoever during execution of work.  - **1.** For construction works which are likely to generate malba/rubbish to the tune of more than a tempo/truck load, contractor shall dispose of malba, rubbish & other

2. DUTIES & POWERS:

Any written instruction or written approval given by the Site Engineer(s) to the contractor within the terms of such delegation (but not otherwise) shall bind the contractor and the Institute as though it had been given by the Engineer-in-charge provided always as follows:
 - a. Failure of the Site Engineer(s) to disapprove any work or materials shall not prejudice the power of the Engineer In-charge to subsequently disapprove such work or materials and to order the pulling down, removal or breaking up thereof.
 - b. If the contractor is dissatisfied by reason of any decision of the Site Engineer(s), he shall be entitled to refer the matter to the Engineer- in-charge, who shall thereupon confirm reverse or vary such decision.

3. ASSIGNMENT & SUBLETTING:

The contractor shall not assign the contract or any part thereof or any benefit or interest therein or there under without the written consent of the Engineer In- charge. The whole of the works included in the contract shall be executed by the contractor except where otherwise provided in the contract. The contractor shall not sublet any part of the works without the written consent of the Engineer In- charge and such consent, if given, shall not relieve the contractor from any liability or obligation under the contract, and he shall be responsible for the acts, defaults and neglects of subcontractor, his agents, servants or workmen, as if they were the acts, defaults or neglects of the contractor provided always that the provision of labour contracts on a piece work basis shall not be deemed to be a subletting under this clause.

4. PROPOSED ACTION IN CASE OF AN ACCIDENT AT SITE:

In case of any serious accident at work site, the Institute may cause an enquiry / investigation into the accident and depending on the outcome of such enquiry / investigation, the institute may take such action against the contractor as may be deemed fit and appropriate in the discretion of the Director, IIT Ropar which may also lead to termination of the contract, and / or forfeiture of the security deposit made by the contractor, and / or the contractor may be may be debarred from applying for future works in the campus for a specified period.

5. LOCATION

6. RELATED DOCUMENTS

In case any item/items or part thereof are not covered under these specifications, the same shall be carried out as per relevant part of the **CPWD General Specification for Electrical Works amended up to date**-CPWD Part-I 2013, Relevant Indian Electricity Rules and Indian Electricity Act amended up to date; Relevant BIS specifications amended up to date; NBC 2016 amended up to date and ECBC-2017 amended up to date and as per direction of Engineer-in-Charge.

These additional specifications are to be read in conjunction with above and in case of variations; specifications given in this additional condition shall apply. However, nothing extra shall be paid on account of these additional specifications and conditions, as the same are to be read along with schedule of quantities for the work.

7. Terminology

The definition of terms used in these specifications shall be in accordance with relevant IS. All components shall conform to relevant Indian Standard Specifications, International Standards and shall bear the stamp of the testing laboratory wherever existing and amended to date.

8. Order of Preference:

In case of discrepancy, if any, between the description of items as given in the Schedule of quantities, technical specifications for individual items of work (including additional and commercial conditions) and IS Codes etc., the following order of preference shall be followed:

- i. Schedule of quantities
- ii. Special Conditions
- iii. Technical specifications specified in the tender
- iv. General Conditions of Contract for CPWD Works
- v. Drawings
- vi. CPWD General Specifications
- vii. Relevant IS or any other International code in case IS code is not available.
- viii. Manufacturer's Catalogue, Specifications and Recommendations.

9. Site Information

The work shall be carried out in a location, and working time may be restricted by the client, claims for idle labour(s) will not be entitled. The Bidder should in his own interest visit the site and get themselves familiarize with the site condition..

10. Completeness of the tender, submission of programme, approval of drawings and commencement of work

I. Completeness of the tender:-

All sundry equipments, fittings, assemblies, accessories, hardware items, foundation blots, supports, termination lugs for electrical connections, cable glands, junction boxes and all other items which are useful and necessary for proper assembly and efficient working of the various equipments and components of the work shall be deemed to have been included in the tender, irrespective of the fact whether such items are specifically mentioned in the tender or not.

II. Safety Codes and Labour Regulations

In respect of all labour employed directly or indirectly, for the execution of work, the contractor at his own expense, will arrange for the safety provisions as per the statutory provision, B.I.S. recommendations, factory act, and workman's compensation act. CPWD code and instructions issued from time to time. Failure to provide such safety requirements would make the bidder liable for penalty. In addition the Engineer-in- charge, shall be at liberty to make arrangements and provide facilities as aforesaid and recover the cost incurred thereon form the contractor.

The contractor shall provide necessary barriers, signals and other safety measures wherever necessary so as to avoid accident. He shall also indemnify CPWD against claims for compensation arising out of negligence in this respect. Contractor shall be liable, in accordance with the Indian law and Regulations for any accident occurring due to any cause. The department shall not be responsible for any accident occurred or damage incurred or claims arising there form during the execution of work. The contractor to cover the risk. No extra payment would be made to the contractor due to the above provisions thereof.

11. General security restrictions are given as under:

- **a.** No inflammable materials shall generally be stored at site of work.
- **b.** The movement of trucks and vehicles will be regulated in accordance with rules and regulations as approved by competent authorities.
- **c.** The contractor shall inform in advance, the truck registration number, ownership of the trucks, names and address of the drivers and labour for necessary action by the security agency.
- **d.** Due to the site conditions, no space for construction of storage facilities and stay of site staff may be allowed.
- **e.** Names and addresses of labourers/staff along with identity proof and residence address proof etc. working at site shall be furnished in advance for security verification for issue of passes.
- **f.** The labourers/staff should not be changed too frequently once the verification of the character and antecedents is done.

- **g.** As and when there will be security requirements, certain additional restrictions can be proposed as per the requirement of the situation.
- **h.** IDENTITY CARDS:- The identity cards will be issued to the workmen employed by the contractor after proper police verification for which Contractor shall submit a list of worker's to be deployed on site of work. The cost of photos would be borne by the contractor. They will be required to carry the identity- cards with them during their working inside the building.
- **i.** Due to security constraints, all the working personal may not be allowed to carry the mobile phone or any other electronic gadgets. The instruction of security personal in this regard shall be followed religiously.
- **j.** Therefore in view of the situation explained under above paragraphs the bidder must visit the site and must get himself acquainted with the proposed site of work, study specifications and conditions carefully before tendering rates. Nothing extra shall be paid on account of compliance of any of these clauses. The hindrance due to security constraints shall be not be accounted towards adjustment of completion time mentioned in the tender document.

12. Works to be arranged by the department

Unless otherwise specified in the tender documents: Space for accommodating all the equipment and components involved in the works, shall be arranged by the Department. However, arrangement to make it lockable and its watch & ward shall be made by the contractor himself.

13. Works to be done by the contractor

Unless otherwise mentioned in the tender documents, the following works shall be done by the contractor and therefore, their cost shall be deemed to be included in their tendered cost- whether specifically indicated in the schedule of work or not: -

- a. Suspenders, brackets and supports for suspending lights and cables etc.
- b. Sealing of all floor slab/wall openings provided by the Department or made by the contractor for laying pipes & cables from fire safety points of view.
- c. Painting of all exposed metal surfaces of equipments and components with appropriate colour as per relevant part of bid document.
- d. Making opening in the wall/floors/slabs or modifications in the existing openings wherever provided for cable/cable tray etc. Opening in the slab/retaining walls/brick wall etc. shall be made by means of core cutting machines only.

- e. All electrical works including cable/wires, earthing etc. beyond power supply made available by the department.
- f. Making good all damages caused to the structure during installation and restoring the same to their original finish.
- g. Approval from Local Body as may be required as per local by-laws. (The contractor's responsibility shall be limited to the work executed by him.)
- h. The water and power supply for installation, testing and commissioning of the complete installation shall be made available by the contractor themselves.

14.Rates

The rate quoted by bidder, shall be firm and inclusive of all taxes including GST, duties and levies and all charges for packing, forwarding insurance, freight and delivery, installation, testing, commissioning etc. at site including temporary constructional storage, risks, overhead charges, general liabilities / obligation etc. No separate reimbursement shall be made on this account. However, statutory deductions shall be made from the bills, as per rule. The rates quoted by the bidder shall also be inclusive of all this, nothing extra shall be paid on this account.

15.Taxes and duties

Statutory deduction on account of GST, Income Tax, Labour Welfare Cess etc, as applicable on Original work, (Except credit items) shall be made at source from each running /final bill payment. A certificate of TDS shall be issued by the department to the contractor.

16.Execution

a. Machinery for Erection

All tools and tackles required for unloading/handling of equipments and materials at site, their assembly, erection, testing and commissioning shall be the responsibility of the contractor.

b. Dispatch of Materials to Site and their Safe Custody

The contractor shall dispatch material to site in consultation with the Engineer-in-Charge. Suitable accommodation shall be made available free of charge temporarily. The arrangement to make it lockable/secure by means of partitions, locks etc. shall be responsibility o the contractor. Watch and ward however, shall be the responsibility of contractor. Program of dispatch of material shall be framed keeping in view the building progress. Safe custody of all machinery and equipment supplied by the contractor shall be the responsibility of the contactor till final taking over by the department.

c. Extent of Work

The work shall comprise of entire labour including supervision and all material necessary to meet a complete installation and such tests and adjustment and commissioning, as may be required by the department. The term complete installation shall not only mean major items covered by the specification but all incidental sundry components necessary for complete execution and satisfactory performance of installation with all layout charts whether or not those have been mentioned in detail in the tender documents in connection with this contract as this is a turnkey job.

d. Compliance with Regulations and Indian Standards:

All works shall be carried out in accordance with relevant regulation, both statutory and those specified by the Indian Standards related to the works covered by this specification. In particular, the equipment and installation will comply with the following:

- a. Factories Act.
- b. Indian Electricity Rules.
- c. B.I.S. & other standards as applicable.
- d. Workmen's compensation Act.
- e. Statutory norms prescribed by local bodies like CEA, PSPCL, and Local Bodies etc.
- **f.** Nothing in this specification shall be construed to relieve the successful bidder of his responsibility for the design, manufacture and installation of the equipment with all

accessories in accordance with currently applicable statutory regulations and safety codes.

g. Successful bidder shall arrange for compliance with statutory provisions of safety regulations and departmental requirements of safety codes in respect of labour employed on the work by the bidder. Failure to provide such safety requirement would make the bidder liable for penalty of Rs. 500/- for each default. In addition, the department will be at liberty to make arrangement for the safety requirements at the cost of bidder and recover the cost thereof from him.

h.Indemnity

The successful bidder shall at all times indemnify the department, consequent on this works contract. The successful bidder shall be liable, in accordance with the Indian Law and Regulations for any accident occurring due to any cause and the contractor shall be responsible for any accident or damage incurred or claims arising there from during the period of erection, construction and putting into operation the equipments and ancillary equipment under the supervision of the successful bidder in so far as the latter is responsible. The successful bidder shall also provide all insurance including third party insurance as may be necessary to cover the risk. No extra payment would be made to the successful bidder on account of the above.

i. Co-ordination with other Agencies

The contractor shall co-ordinate with all other agencies involved at the site of work so that the work of other agencies is not hampered due to delay in his work. The work, which directly affects the progress of work of other agencies, shall be given priority.

j. Quality of Materials and Workmanship

- **i.** The components of the installation shall be such design so as to satisfactorily function under all conditions of operation.
- **ii.** The entire work of manufacture/fabrication, assembly and installation shall conform to sound engineering practice.
- iii. All equipments and material to be used in work shall be manufactured in factories of good repute having excellent track record of quality manufacturing, performance and proper after sales service.
- iv. All equipments and materials to be used in the work shall be brand new having its date of manufacturing not more than 6 months old from the date of delivery at

site with manufacturer's certificates, warrantee cards, technical catalogues, instructions, manuals and wiring diagrams etc.

17. Guarantee

The contactor shall guarantee the complete system to maintain the specified conditions under all conditions of ambient temperature.

- **a.** The contactor shall guarantee the complete system to maintain the specified conditions under all conditions of ambient temperature.
- **b.** All equipments shall be guaranteed for a period of at-least One year or as per Manufacturer's standard whichever in more, from the date of acceptance and taking over of the installation by the department against unsatisfactory performance and/ or breakdown due to defective design, material, manufacture, workmanship or installation. The equipment or component or any part thereof so found defective during the guarantee period shall be repaired or replaced free of cost to the satisfaction of the Engineer-in-Charge. In case it is felt by the department that undue delay is being caused by the contactor in doing this, the same will be got done by the department at the risk and cost of the contractor. The decision of Engineer-in-Charge in this regard shall be final.
- **c.** LED items shall have warranty of 1 year by the OEM from the date of installation.

18.Terms of payments:

Following payment terms shall be applicable.

a. No advance payment shall be made and payment against bills shall be admissible.

19. Special condition for safety at the work site

The contractor will identify one of the supervisors for taking care of implementation of Safety systems. The Contractor should follow the following General Guidelines governing the safety rules as laid down under:

- **a.** Smoking is strictly prohibited at the workplace.
- **b.** Nobody is allowed to work without wearing a safety helmet. Chinstrap of the safety helmet shall be always on. Drivers, helpers and operators are no exception.
- **c.** No one is allowed to work at or more than three meters height without wearing safety belt and anchoring the lanyard of safety belt to firm support preferably at shoulder level.

- **d.** No one is allowed to work without adequate foot protection. Usage of eye protection equipment shall be ensured when workmen are engaged for grinding, chipping, welding and gas-cutting. For other jobs as and when site safety co-coordinator insists eye protection has to be provided.
- **e.** All safety appliances like Safety shoes, Safety gloves, Safety helmet, Safety belt, Safety goggles etc. shall be arranged before starting the job.
- **f.** All excavated pits shall be barricaded & barricading to be maintained till the backfilling is done. Safe approach is to be ensured into every excavation.
- **g.** Adequate illumination at the workplace shall be ensured before starting the job at night.
- h. All the dangerous moving parts of the portable / fixed machinery being used shall be adequately guarded.
- **i.** Ladders being used at site shall be adequately secured at bottom and top. Ladders shall not be used as work platforms.
- **j.** Material shall not be thrown from elevated positions. If required, the area shall be barricaded and one person shall be posted outside the barricading for preventing the trespassers from entering the area.
- **k.** Other than electricians no one is allowed to carry out electrical connections, repairs on electrical equipment or other jobs related thereto.
- **1.** All temporary electrical connections shall be made using 3 or 5 core cables, having an earth wire.
- **m.** Inserting of bare wires for tapping the power from electrical sockets is completely prohibited.
- **n.** A tools and tackles inspection register must be maintained and updated regularly.
- **o.** Debris, scrap and other materials to be cleared from time to time from the workplace and at the time of closing of work every day.
- **p.** All the unsafe conditions, unsafe acts identified by contractors, reported by site supervisors and / or safety personnel to be corrected on priority basis.
- **q.** No children shall be allowed to enter the workplace.
- **r.** All the lifting tools and tackles shall be stored properly when not in use.
- **s.** Return cables shall be used for earthing. Lamps shall be used on Return cables to ensure proper earthling for welding works.
- **t.** All the pressure gauges used in gas cutting apparatus shall be in good working condition.

- **u.** Connectors and hose clamps are used for making welding hose connections.
- **v.** Proper junction boxes must be used for tapping of power for temporary use.

20. Quality assurance plans:

a. internal & external electrical work:

- i. For Internal and External electrical works, the bidder should have **valid electrical contractor license** from competent authority in the name of the contractor.
- **ii.** Sample of materials like pipe, conduits wires, of each size etc. may be got tested in the laboratory approved by Engineer -in charge, as and when desired by Engineer-in-charge. All the materials intended to be used in the work shall be got approved by Engineer-In-Charge before use at site.
- **iii.** Fish wire shall be provided in each conduit where wiring is not carried out.
- **iv.** Extra item, substitute item, deviation etc. shall be carried out only with written permission of competent authority.
- **v.** Necessary documents of handing / taking over of the installation will be duly signed by the parties namely Engineer Incharge and the main contractors.
- vi. The contractor will have to ensure that the skilled / Semi skilled labour, engaged in the execution of the work must possess valid electrical license / qualifications else will not be permitted to execute the work.
- vii. The contractor shall be responsible for removal of all defects in the work during the defect liability/guarantee/warranty period. The department shall carry out routine maintenance only. However, if any failure is noticed during this period which is attributable to poor quality of material and bad workmanship, the contractor will be required to rectify the same at his own cost, failure of which the department will be at liberty to get the defects rectified at the risk & cost of the contractor. The contractor will also be required his own inspection/testing during the to carry out guarantee/warranty period and attend to any defect taking place during this period.
- viii. Material required for the work shall be brought at site at the appropriate time keeping in view the requirement of material depending on progress of the work.
 - **ix.** The work shall be carried out as per direction of Engineer -in-charge and CPWD specifications for Electrical Works.

- **x.** Taxes, levies etc. as applicable shall be deducted from the contractor's bill. No Road Permit or other forms shall be issued by the Department. The rates quoted shall be inclusive of all taxes, duties, levies, T & P and petty items like including log book, complaint register duster, Mobil oil, test lamp etc. and no advance payment will be made.
- **xi.** The materials supplied shall be new (Manufactured not earlier than 6 months before the date of tender opening) and ISI marked wherever applicable. Test certificate / reports and warranty certificates as required shall be provided by the agency to the entire satisfaction of Engineer-in-Charge before bill submission for payment.
- **xii.** The labour deployed site for execution of work shall take all safety precautions and the contractor shall be responsible for compliance of all labour regulations, liabilities and safety measures. If the Institute is not satisfied with the performance of labour, then alternate staff is to be provided immediately.
- **xiii.** All required documents shall be provided for verification of the staff deployed at site for execution of work.
- **xiv.** The contractor shall be required to possess during the full currency of the contract a valid license for employing contract labour from the appropriate licensing authority under the contract labour (Regulation and abolition) act 1970. The contractor shall be solely responsible for compliance of various statutory obligation (including the financial liabilities) under contractor labour regulation & abolition Act. Minimum wages act etc. and other applicable laws and rules framed their under from time to time. Contract workers are to be paid not less than fair wages which means wages fixed by CLC, Govt. of India under the provisions of the Minimum Wages Act. Wages due to the worker shall be paid to him directly by the contractor through Bank or ECS or Online transfer to his bank account and receipt of wages shall be attested by the worker concerned.
- **xv.** The contractor shall depute 01 (ONE) nos. Supervisor (Engineer/Technician having minimum 2-year experience) who shall remain present at site throughout the period of execution of work, failing which recovery shall be made from the contractor in the event of not fulfilling provision at the rate of Rs. 10,000/- Per Month / per person.

- **xvi.** The contractor will have to arrange his own T & P required for the work. The department will not arrange any T & P and nothing shall be paid on this account. The Site service personnel should possess the following:
 - **1.** Line Tester, Test Lamp
 - 2. Spanner Kit.
 - **3.** Crimping Tools
 - 4. Multi Meter & Tong Tester
 - 5. Lux Meter (Digital)
- **xvii.** No residential accommodation shall be provided to any of the staff engaged by the contractor. The contractor shall also not be allowed to erect any temporary set up for staff in the campus.
- xviii. The Site Engineers and all deputed staff shall carry mobile telephones(s) (unless otherwise specifically instructed by the institute for safety reasons) to enable the Engineer-in- charge or his representative to have easy and quick communication. Nothing extra shall be paid on account and his quoted rates for various items under this contract will be inclusive of this obligation. Contractor is bound to give all the telephone no. of their staff deployed at site to the Engineer in charge, immediately after award of work.
 - **xix.** Safety codes and Labour Regulations:- In respect of all labour employed directly or indirectly on the work for the performance of the contractor's part of work, the contractor at his own expense, will arrange for safety provision as per the statutory provisions, B.I.S. recommendations, factory act, workman's compensation act, CPWD code and instruction issued from time to time. Failure to provide such safety requirement would make the bidder liable for penalty as per Part-A for each default. In addition the Engineer-in-charge, shall be at liberty to make arrangements and provide facilities as aforesaid and recover the cost from the contractor. Safety of the staff employed will be the responsibility of the contractor. CPWD will not be responsible for any mishap, injury / accident or death of the staff. No claim in this regard shall be entertained / accepted by the department.
 - xx. Contractor shall be fully responsible for any damages caused to govt. property or allottee's property by his or his labour during the carrying out the work. All such damages shall be rectified by the contractor at his own cost, failing which the same will be got rectified by Engineer-in-charge and the expenditure

incurred shall be recovered from the contractor bill. The watch and ward of installation shall be the responsibility of the contractor.

- **xxi.** Contractors are requested to inspect the site before quoting their rates for the tender; later on no further claims in this regard shall be entertained.
- **xxii.** The staff engaged has to be courteous and maintain good behavior at site. Any person find discourteous or misbehavior shall have to be replaced within 48 hours, failing which, the Engineer- in-Charge has the power to cancel the contract, and the contractor shall have no claim of compensation. Decision of the Engineer-in-Charge shall be final and binding on the contractor. The contractor shall submit the name, address & character certificate of the worker/ staff employed by them at the site of work to the Engineer-in-Charge before start of the work.

21.List of approved makes

The materials of first quality from the list provided in **Annexure B**, having minimum local content as per DPIIT PPP-MII ORDER are to be used. In case it is established that the brands specified below are not available in the market, contractor shall submit alternative proposal for the approval of the Engineer- in-Charge. When two or more alternative brands have been mentioned, the brand to be finally used shall be as decided by the Engineer-in-Charge and as per sample approved before procurement & Installation. The contractor shall submit samples of all materials within 7 Days before procurement for approval and shall procure directly from the manufacturer or their authorized distributor / dealers only.

22. SCOPE OF WORK:

The scope of work will include supply, installation, testing, commissioning and performance testing of LED sports lighting system, electrical outdoor panel with suitable Cabling for the hockey field at the sports complex in IIT Ropar permanent campus in accordance with requirements documented in BOQ and technical specifications attached herewith in the corresponding section of the tender documents.

The contractor should also Extend the available 8 mtr pole by 1 mtr for lighting arrangement with 5 " dia MS pipe along with base plate of size 300x300x12 mm duly welded complete as required with painting and should provide foundation as specified in BoQ.

In addition to the above scope covers the following activities, though not limited to and all associated works, services as may be required to complete the installation in all respects within the specifications.

- **i.** The contractor / OEM shall have to offer a direct 1 year free replacement on-site warranty towards the installed sports lighting system.
- ii. The lighting head frame shall have provisions to increase the light levels to Class
 II (Eh ≥ 500 Lux) at a later period by increasing only the number of LED lights.
- **iii.** The final achieved light levels and readings etc. shall be carried out by the OEM authorized engineer and certificate to that effect shall be issued.
- **iv.** LED sports floodlight luminaries shall be of outdoor type complete with accessories.
- **v.** Wire harness complete with plug in connectors provided inside the pole for electrical connections from the driver unit up to each flood light.
- vi. The work includes design, SITC of head frame of suitable size to accommodate a minimum of 4 Flood light fittings.

23. DESIGN PARAMETERS:

The illumination levels and associated parameters shall meet the following requirements of Class-III (\geq 300 Lux). The system shall have provisions to increase the light levels to Class-ll (\geq 500 Lux) at a later date by increasing only the number of LED Lights.

All illumination values shown above are constant light levels to be maintained over a period of 10 years. A maintenance factor of 0.85 should be used to guarantee the maintained illumination levels.

ii. Detailed technical specifications of led lighting system

This section provides technical specifications of various constituents of the LED lighting system. The products and equipments offered by the bidder must conform to these specific requirements in addition to the stipulations of applicable standards / norms.

- 1. Floodlight LED Luminaire
 - a. The LED floodlight luminaires shall be of special design for sports lighting application.
 - b. The floodlights must have IES TM-21-11 testing for projected lumen maintenance or NABL certified LED fixturés along with LM 79 & LM 80 certification. The floodlight shall be of heavy and robust construction considering the required heat sinks etc.
 - c. The floodlight shall consist of die-cast aluminium housing providing a rugged base and facilitating sophisticated photometric unit to prevent direct glare from the LED light source.
 - d. The floodlight shall be a state-of-the-art design allowing easy mounting.
 - e. The unit shall have a degree of protection of IP-66 allowing protection against ingress of dust, solid objects and water/moisture.
 - f. The photometric pattern shall provide optimal energy efficiency and minimal spill light and its visor should allow energy efficient light on the field preventing glare.
 - g. The front glass shall be made of tempered glass lens for resistance to thermal and mechanical shock.
 - h. To prevent the mounting cross-arms from sagging resulting in potential floodlight misalignment and to allow easy maintenance the driver and other electrical accessories shall be mounted in a remote outdoor type electrical enclosure box at the base of the mast.
 - Each floodlight luminiare shall be attached to the cross arm by a minimum of two (2) bolts, which shall be of stainless steel and there shall not be any penetration of the top or sides of the cross arms for mounting the floodlights.

- j. To assure quality of lighting on the field is maintained, light fixtures shall have a positive repositioning device for each luminaire on the assembly. The device shall provide for automatic repositioning of the aiming after relamping. In addition, there shall be a stainless steel bolts and nuts to secure the alignment.
- k. The floodlight shall have Class-H electrical insulation for complete safety.
- 1. The floodlight should have improved material and gasket system to virtually eliminate out gassing and contamination of the reflector and lens.
- m. Type Test Report from a NABL accredited LAB should be submitted.
- 2. Light Source
 - a. The light source for floodlight luminaries shall be LED arranged in a suitable array.
 - b. The LED shall be of minimum 4000Kcolor temperature and minimum 70Ra CRI
 - c. The LED shall have instant ON-OFF capabilities.
 - d. The LED which fails during the warranty period should be replaced and installed at site within 7 days at no extra cost.
- 3. LED Driver and Electrical Enclosure
 - a. The driver shall functionally match with the LED floodlight by the bidder and must have been successfully been used for similar sports lighting projects. The driver should conform to UL testing for 50 deg. C ambient temperature operations.
 - b. The driver, surge suppresser, fuse and circuit disconnectors shall be mounted in an outdoor type enclosure made of aluminum sheet, duly power coated with high performance polyester, having a degree of protection minimum IP- 66,
 - c. For easy identification and reduced maintenance time, each driver, wire, cable, fuse, etc. shall be labeled to identify the floodlight luminaries it controls.
 - d. The driver gear electrical enclosure shall be mounted on each pole with suitable mounting arrangement to prevent ingress of water.
- 4. Internal Wiring
 - a. To protect from deterioration resulting from exposure to the harsh atmospheric conditions, all wiring for LED floodlights shall be contained inside the cross arms or poles and no external wiring even if provided with flexible conduits is acceptable.

- b. To protect wire harness from expensive and time-consuming repairs caused by strain on the connection, the wire harness shall be supported at the top of the pole and in the middle by a stainless steel wire mesh grip matched to the size of the harness.
- c. To eliminate the wire harness from being accidentally removed, the wire mesh grip shall be mechanically attached to the pole to an enclosed snap hook.
- d. The internal wiring shall be of stranded copper conductor having minimum cross section of 2.5 sqmm, colour coded for easy identification and shall include abrasion protection sleeve, strain relief and plug in connections.
- 5. General Requirements
 - a. All components shall be designed and manufactured as a system. All luminaries, wire harnesses, drivers and other enclosures shall be factory assembled, aimed, wired and tested.
 - b. All exposed components shall be constructed of corrosion resistant material and/or coated to help prevent corrosion. All exposed steel shall be hot dip galvanized. All exposed hardware and fasteners shall be stainless steel of at least 18-8 grade, passivity and polymer coated to prevent possible galvanic corrosion to adjoining metals. All exterior reflective inserts shall be anodized, coated with a clear, high gloss, durable fluorocarbon, and protected from direct environmental exposure to prevent reflective degradation or corrosion. All wiring shall be enclosed within the cross arms, pole, or electrical components enclosure.
 - c. During material handling, transportation, erection, etc. the at most care shall be taken so that no damage or scratch or mark occurs on any parts. If occurred, necessary action shall be taken by contractor.
 - d. Cable and wire selection should be done so that maximum 60% of loading is achieved. Selection of power cables shall be sized to restrict the voltage drop to 3%. The supply and installation of Gland and Lugs needed for termination will be in scope of Contractor. Cable size shall be decided by keeping maximum 60% load. All the cables shall have gland and lugs.
 - e. The system of wiring shall consist of PVC insulated copper stranded conductor flexible FRLS wires in metallic conduits in exposed and FRLS PVC conduit shall be used in concealed. Wires originating from two different phases shall not run in the same conduit. All wires shall have ferrules 'for identification.

- f. Minimum wiring size of FRLS copper conductor shall be 2.5 sq mm for light fitting and 4 sq mm for power.
- g. Electricity and water required for work will be provided by institute at one point on chargeable basis (as per institute norms) or contractor can arrange the same on his own risk and cost.
- 6. Defect Liability Period:
 - a. The equipment should be covered comprehensive on-site warranty against any manufacturing defect for a period of 1 Year from the date of successful installation and acceptance. In case any part or whole of the equipment is found to be defective during the DLP period, then the same will have to be replaced/repaired free of cost at our premises. Warranty certificate should be submitted with the bill(s).
- 7. Insurance:
 - a. Necessary insurance cover will be in the scope of Contractor. The date of delivery should be strictly adhered to failing which the work order is liable to be cancelled.
 - b. Penalty may be imposed as per terms & conditions. Goods should be securely, safely and adequately packed & dispatched and delivered at the risk of supplier. In case of damage consignment the same should be replaced without any cost to the Buyer and the supplier can collect the damaged consignment after satisfactory replacement.
- 8. Inspection:

Engineer In charge will decide whether inspection of materials before delivery is required or not. If inspection is required, the Vendor will give sufficient advance notice of the date in writing on which the goods will be ready for inspection. If due to any reasons, it is not possible on the part of the purchaser to visit the plant/ site of the Vendor for inspection of the items, the Vendor shall share the detailed schematic diagram, pictures of item and the details as required by the IITP.

9. Test Certificates:

Manufacturing test certificates & Type test certificates should be submitted with material.
