NOTICE INVITING QUOTATION

1. ELIGIBILITY CRITERIA:-

- Contractor who fulfill the following requirements shall be eligible to apply:-
 - Should have satisfactory completed the works as mentioned below during the last seven years ending the last day of submission of application.
 - 3 (three) Similar Works* each of value not less than 40% of the estimated cost put to quotation.
 - 2(two) Similar Works* each of value not less than 60% of the estimated cost put to quotation.
 - 1(one) Similar Works* value not less than 80% of the estimated cost put to quotation.
 - *Similar Works means "Commercial exhaust hood with baffle filters"
 - b) Enlistment contractors of appropriate class in Central & State Government Organization.
 - c) Joint Ventures are not accepted.
- ii. Documents to be submitted with the Quotation:
 - Enlistment order of the contractor/ Registration of firm.
 - Required experience/ completion certificate of works as stated in similar works above.
 - c) GST Registration.
 - d) PAN registration with Income Tax Department.
 - e) Price quoted in the Prescribed Format "A". Signed and stamped.
 - f) Signature & stamp.

Envelope of sealed quotation to mention of Name of work, date & time of opening of quotation.

- The bidder should visit the quarters and understand the complete scope of work before quoting their rates.
- The Quotation shall be submitted in quotation box placed in the office of the Deputy Registrar (S&P), 2nd floor, Vishveshwaraya Block, IIT Ropar Birla Farms, Permanent Campus, Rupnagar 140001 on or before 28.08.2019 upto 3:00 PM & shall be opened on the same day at 3:30 PM in the presence of contractors or their representatives, who may like to present.

- 4. The quotations received through E-mail shall not be entertained.
- 5. Prices should be quoted in the prescribed Format "A". No advance payment will be made to the agency.
- Conditional quotation shall be rejected.
- Duration of work shall be 07 days from the issue of work order.
- The quotation shall be valid for 30 days.
- 9. The rate quoted shall be inclusive of all taxes including Goods and Services Taxes (GST).
- Nothing extra will be paid to the agency by the Institute.
- 11. The work can be terminated at any time without giving any reason and notice.
- Debarred agency/ or individual shall not to participate in the Quotation process.
- Quotationers may inspect the site of execution of work before submission of quotation to understand the scope of work in all respects.
- 14. The quantities of items in schedule are tentative which may increase of decrease depending upon site conditions.
- Security deposit @ 2.5% of value of work done shall be deducted and released after satisfactory completion of defect liability period of 12 months from the date of completion of work.
- Penalty @ 1.5% per day upto a maximum of 10% of the tendered value shall be imposed for delay in work beyond stipulated date of completion.
- 17. The Director, IIT Ropar reserves the right to cancel any or all the quotations without assigning any reason.

- 19. Arbitration: In the unfortunate situation if any all disputes, disagreement and controversies arising in any manner, which cannot be settled by mutual agreement between the two parties, shall be resolved through arbitration. The number of arbitrators shall be ONE, shall be appointed by Director, IIT Ropar. The decision of sole arbitrator shall be final and binding to both the parties. All provisions of Arbitration and Conciliation Act 1996 (with amendments) shall apply and the legal place of arbitration shall be Rupnagar, Punjab. The language of arbitration proceedings shall be English. The Court which have jurisdiction in the matter is District Court, Rupnagar, Punjab.
