Subject: Letter of Intent for running of Cafeteria in Utility Block, Permanent campus of IIT Ropar.

Reference your bid against abovesaid tender. Director, IIT Ropar is pleased to award you contract for IIT Ropar initially for a period of 01 year w.e.f 10.02.2021 to 09.02.2022. The contract is awarded subject to the following terms and conditions in addition to the terms & conditions mentioned in the tender document:-

- 1. You will charge the rates of food items as per "Annexure A".
- 2. You will pay licence fee as decided by the Institute and also pay the electricity charges for the cafeteria kitchen and office/cash counter area allotted as per the consumption. The electricity used in the common sitting area shall not be chargeable but upkeep and switching off electricity shall be responsibility of the agency. However, 50% electricity bill as per actual use will be waived off during the vacation period. The institute reserves the right to amend the percentage of rebate on electricity charges. The vacation period may be calculated as per the academic calendar of the Institute. The license fee and electricity charges would be communicated to you separately by the Work & Estate Division.
- 3. You will maintain the cafeteria as per the directions of the Chairman, Utility Management Committee /the authorized person of the Institute. If the services found to be satisfactory during this period, the contract can be further extended.
- 4. You will deploy sufficient manpower to take care of the Cafeteria as per conditions of the contract as contained in the tender document.
- 5. You should fulfil all the statutory requirements provided by the acts governing labour laws such as Payment of Wages Act 1936, Contract Labour (Regulation & Abolition) Act 1970, Minimum Wages Act 1948, Child Labour (Prohibition & Regulation) Act 1986, etc and any other such relevant acts & provisions thereof. Also it is your duty ensure that all the Govt. policies are being followed.
- 6. You will not sublet/award canteen to anyone.
- 7. Housekeeping of the common area will be your responsibility at your cost only.
- 8. Quality is the essence of the contract as per the scope of the work. In case of any lapse in the services, the contract shall be cancelled as per the terms and conditions mentioned in the tender document.
- 9. The service hours in the canteen shall be as follows: From 8:00 AM to 2:00 AM (Till another cafeteria is not established, and after that, this timing may change from 8:00 AM to 11:00 PM, this will be done with prior notice).

- 2. Agreement on non-judicial stamp paper of the requisite value for providing the above services as per Annexure "B" of the tender document.
- 3. Undertaking duly signed on the company letter head as per Annexure "A" of the tender document.
