With reference to your tender bid against tender notice no. 1340-19/IITRPR/PS/ dated 05.04.2019, the Competent Financial Authority is pleased to award you the contract for Removal of Wastage and Garbage for Transit Campus-I and Permanent Campus of IIT Ropar for a period of 02 years w.e.f 19.07.2019 @ Rs. 1,16,000/- per month exclusive of GST. The contract is awarded subject to the following terms and conditions in addition to the terms & conditions mentioned in the tender document:-

- 1. The outdoor dustbins will be provided by you at the start of contract to maintain uniformity of dustbins in the campus.
- 2. You will provide 70 nos. outdoor dustbins of green colour, 100 kilogram capacity with lid and fixed non swinging stand and mark serial numbers on each dustbin.
- 3. You will provide uniforms to the garbage collection staff.
- 4. The garbage collection staff should be in proper neat and clean uniform, shoes, gloves and face mask.
- 5. You should get the dustbins cleared on daily basis.
- 6. You will provide polythene in all the dustbins and no dustbin will be left without polythene.
- 7. Carrying the garbage out of IIT Ropar Campuses and its disposal at an environmentally safe place.
- 8. Loading of garbage from dust bins to trolley with labour on daily basis without any break.
- 9. Cleaning of dust bins placed in campuses, placing of proper sign boards and reporting of the same to the representative of IIT Ropar.
- 10. Garbage is to be collected everyday from all the designated points without any break. In the event of failure to carry the garbage in terms of non-lifting or partial lifting on any day, the institute will be free to make its arrangement for that day besides deducting a penalty of Rs. 5,000.00 per day for this lapse.

- 2. Agreement on non-judicial stamp paper of requisite value for providing the above services.
